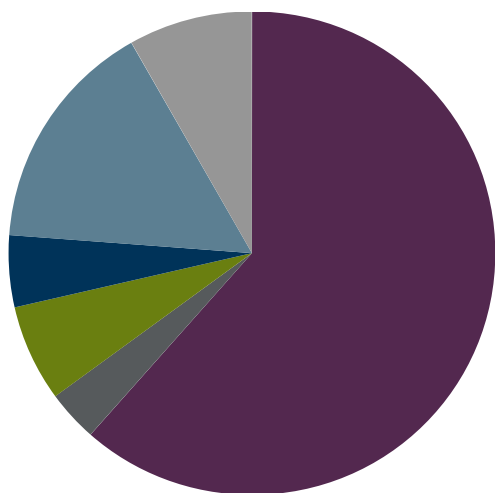

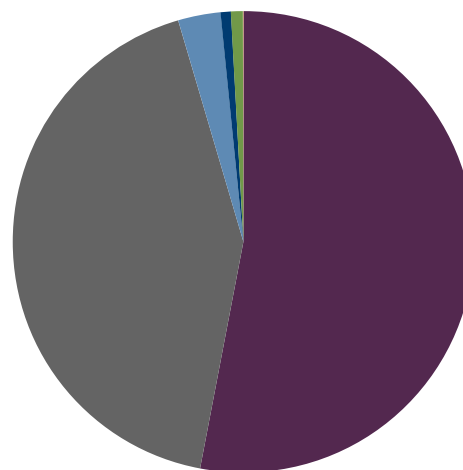

**Solvency Ratio – \$108.86** The Solvency Ratio expresses financial soundness and a company's ability to meet the policy obligations as they come due. The higher the amount, the stronger the company's position to cover unforeseen emergency cash requirements.
